

Message from the Borough Council President

Welcome to the first edition of The Borough of Jim Thorpe's quarterly Newsletter. A special thanks to Junior Council Member Connor Rodgers, who is responsible for coming up with the idea for this Newsletter and for his time in putting it together.

I would like to update and inform residents about three upcoming projects that will serve the needs of the borough for many years to come. The three projects center around the transformation of the Memorial Park complex. The Public Service Department will be vacating the grounds of Memorial Park and will move to a new building on the west side of town on borough lands across from the water treatment plant. The borough is also currently preparing a master site plan for Memorial Park that will encompass the current Public Service Department area. Grant funding will provide new equipment and upgraded facilities for this undertaking. The central theme of the park complex upgrades will be to honor the namesake of the park, our Veterans. The third project involves much-needed repairs and upgrades to Memorial Hall. The Police Station will be moved into the lower level of the Hall. The borough Administrative Offices will move into the front portion of the Hall, with the remaining area maintaining a 200–300 seat open space for community use. The building which currently houses these two offices will be offered for lease by the borough. The building projects are planned to be out for bid this spring.

Delaware and Lehigh Trail Project

In 2018, work began to complete the section of the Delaware and Lehigh trail on the east side of Jim Thorpe near the sewage treatment facility. The work included building a retaining wall and a trail connector from the existing trail, just south of the sewer facility, to the 255' feet county-owned bridge, completed in 2018. The D & L retaining wall and trail, also near the historic lock one of the canal, was \$1,198,272.00. The trail was connected to the Mansion House Bridge after the bridge was closed for nearly a year. The trail opened on August 12, 2019. An official opening ceremony was held in late August 2019 for the project.



After the trail was open for a few weeks, it became clear that additional fencing was needed on the trail connector due to a steep embankment on the river side of the trail. The DCNR grant covered \$36,167.00 for building the fence. Both projects were contracted by Don E. Bower, Inc. With this completion, Carbon is the first county to have a completed trail through the corridor.
