Ordinance 2020-01 - Amendment to Parking Regulations (Section 420-27 of Borough Code)

- Adding parking on the east side of Hemlock Street between West Broadway and the Bus Road.
- Removing parking on the west side of Hemlock Street between West Broadway and the Bus Road.

Ordinance 2020-02 - Amendment to Peddling and Solicitation Exceptions (Section 333-3 of Borough Code)

- Adding a Veterans Exemption to the Peddling and Solicitation Ordinance.
- A permit required and no permit fee to any honorably discharged member of any of the armed services, and who procures and presents the DD-214 form to the Borough.






### Memorial Park Master Site Development Plan Update

Over the past several months, the Memorial Park Master Site Development Plan Committee along with Barry Isett & Associates have been working on developing a plan to update the Memorial Park as well as expand the park into grounds that will no longer be used by Public Service in the next few years. The goal is to create a community park that is new and updated but keeps as much of the current park as possible.

Throughout the process, the committee and BIA have determined the Borough's recreation needs and interests through public surveys, committee meetings, and through online feedback. With the many needs and interests, BIA has provided the committee with three draft concept plans. In order to draft the three concept plans, BIA additionally received input from stakeholders who have used the park on a regular basis. A draft of the final plan was created and presented to the committee and will be presented to the public through a virtual PowerPoint. The public is encouraged to view the plan when it becomes available on June 5<sup>th</sup>.
