#### **Public Hearing**

Kathy Reigel was present to discuss the 2018 CDBG money. She informed the public the purpose of the public hearing is to receive input and comments from the citizens for the use of the 2018 CDBG funds. She informed everyone the anticipated amount for the borough is \$78,711.00 in projects costs and \$17,278.00 in Administration fees, total amount of the grant is \$95,989.00. She said over the next 3 years the borough would like to use CDBG funds to replace storm drains and reconstruction of streets.

#### Mayor's Report

Mayor Sofranko said at the workshop it was discussed about sending a letter to the County Commissioners about the proper signage, disregards sending the letter to the County.

Mayor Sofranko spoke about the parking and School Street no parking ordinance and hiring a part-time officer.

Mrs. Lukasevich asked if the old parking meter posts will be removed?

Police chief Schatz said the posts are there for people to reference where to park.

Mayor Sofranko said they are planning on using the posts to place advertisements, flags, etc. on them.

Mr. Miller asked if the Police could start looking for expired vehicles.

Arlene Dombrowsky, submitted the petition for the paving of 6<sup>th</sup> Street, she said everyone on her side of the road gets water in their basements. She asked if something could be done like putting a grate in coming down from 7<sup>th</sup> St to 6<sup>th</sup> St. or black top. She said 6<sup>th</sup> St is the first street coming down from Fishers Hill. She asked Council to do something to help the residents out.

Mr. Miller said he does not think repaving the street is going to help, it is going to make it worse. There is no curbing there.

Arlene Dombrowsky said they did have a 4-inch black top lip in front of her house before, it has all been washed away. She would like something to be done.

Mr. Miller said curbing is the property owner's responsibility.

Borough Manager Sterner said the public is having a hard time hearing Council. She asked Council and the public to use the microphones to speak so everyone can hear what is being said. She told the public if they cannot hear Council let them know immediately.

Louis Hall, 1490 Broadview Drive, JT Planning Commission Chairman, he updated everyone on what they have been working on:

- VRBO's and ordinance for vacation rental by owners
- Marijuana dispensaries ordinance
- Readdressing
- Sign ordinance a committee has just been set up to do this.
- County project they are working with the Commissioner's
- Permit parking they would like to move forward with this
  As far as the parking study there is no progress report, time frame, if the ordinance needs
  to be amended it can be done. There were a few comments on the ordinance. They would
  like to move forward with this.

Mr. McGuire said he received an update on the study. There is nothing concerning the parking permit ordinance. He will send this report to Council and the Planning Commission to review.

Louis Hall said the parking permit kind of goes hand and hand with the VRBO's

Ed Hughes, Carbon County Commissioners representative for the Susquehanna Street project. They have recommendation of approval from the County Planning & Jim Thorpe Planning Commission.

Kevin Ember from McCarthy Engineering they are the site engineer for the project. They did receive conditional preliminary approval there are some issues they are still addressing. He presented the drawing of the plans for the project to Council. What the County is proposing is demolishing the existing 2 story building on Susquehanna Street and the maintenance building. The County will be cutting into the hillside for the new building. The new structure will be a three-story building. The 1<sup>st</sup> & 2<sup>nd</sup> floor of the building will be used for parking garage, common entrance on the first floor and one door at the main lobby and security area that will split into the proposed building and the 3<sup>rd</sup> floor will be for offices, court rooms etc. for the County. They received the Carbon County Conservation Districts E & S approval, this is under an acre so there is no NPDES permit required, working with Penn Dot for the driveway connection. They did submit the traffic impact assessment, with minor comments.

Mr. McGuire said the driveway connection, what do you mean by that?

Kevin Ember said there is an existing driveway there, for the existing parking lot, because of new driveway connection Penn Dot is requiring a new highway occupancy permit for this driveway. He is not sure if the existing one was ever permitted.

Mrs. Lukasevich asked if the parking is for the employees.

Kevin Ember said employee parking only.

Mr. Miller said the only concern he has is coming in and out of that place.

Eric Bounce said the traffic planning design, the application was submitted in May 2018 to Penn Dot to review the application to take a look at what needs to be done with traffic study. They are happy with the notion that we are taking 2 access points there, one entrance to the north and the exit to the south, they are being removed and only 1 new driveway coming from the parking garage on Susquehanna Street. They like the fact its being reduced to 1 location. The point of traffic the bulk will be entering in the morning and exiting in the afternoon. The biggest concern we heard is everyone leaving in the afternoon. Penn Dot had them do a traffic study. The left-hand turn being the most difficult we had to provide them data to them and they looked at it and they feel it is acceptable to allow that. One point they did discuss was the County staggering some of the end times, so you don't have all of the employees leaving at the same time.

Louise Hall asked if there is going to be a right turn lane?

Eric Bounce said it is not going to be striped as a separate right-hand turn lane. They discussed with Penn Dot, their concern is people being able to see getting in and out of the driveway and they are concerned about some of the off-street parking. They have to eliminate a few of those parking spaces in order to provide the sight distance. It will be painted striping on the roadway so people do not park there.

Bill Malatak asked if the Borough is going to lose any parking spaces over there and how is the Borough going to be compensated for this?

Wayne Nothstein, Carbon County Commissioner, he is requesting a meeting with the manager, 2 or 3 Council members to talk about this issue. This will help with getting more parking in the county parking lot, and this will be more security for them.

Bill Malatak asked County Commissioner Nothstein about the sidewalks and the fence.

Mayor Sofranko said the Borough Manager and himself had a conversation with Commissioner Gerhard, this is being resolved.

Commissioner Nothstein said they are in the process of getting quotes for the lower end of the fence.

Bill Malatak asked what is happening with the Mansion House project and how it is going to affect the traffic and when are they going to start with the mountain side.

Borough Manager Sterner said they won't be starting on the mountain side until next year.

Jerry Strubinger said in regards to the Susquehanna Street project, Council should have more input on this project, this should have 2 more stories of parking there. Fall Foliage festival is it possible to make a left-hand turn lane where the County parking spaces are on Lehigh Ave.

Police Chief Schatz said there is no parking there, you cannot make a left-hand turn, you have to go down and around the square to get into the parking lot. This doesn't tie up traffic.

Jerry Strubinger said the answer to this is a by-pass.

Mayor Sofranko said he will always stand he won't by-pass the business district.
