# Mayor's Report

All received a copy of Police Report.

Civil Service list is coming to an end, there are 1 or 2 candidates. State testing- no cost to borough asking council to approve. JTPD still covering all shifts, fortunate to do so in Jim Thorpe.

Police Committee-debate about parking on Broadway and oversize vehicles. Chief is monitoring ongoing discussion, and vehicle lengths. Discussed car lengths, possible use of "Compact Car Only". This can be determined by VIN number.

Chief Schatz-follow solicitor, ordinance, must define length of car. Mayor request Parking discussion to move forward.

Mark Reitz – not happy with discharge of firearms in Glen Onoko Estates. Shooting has disturbed Peregrine Falcons. Mark Reitz works for many families. Pleasant Hill-electric fence-JTPD Poeldnurk has Flizack on camera at Old Reabold oil delivery garage on a tractor-screaming and yelling-pressed charges-mad about ARI5 shooting-family all disturbed. In the Morning Call today, it reported that a hunter shot somebody at a park thinking they were a ground hog. Talked about bullet holes-possibility of redirection-legal to discharge weapons anywhere-typically one (1) acre lots- (Reitz has biggest lot). Upset with PSP-tell people to go to legal range-no regulations on discharge of weapons.

Dee Reitz – Discharge of firearms in residential zone neighborhoods, mentioned Nesquehoning, referred residents to approved state fire range where people can go. Council voted to advertise to prohibit firing of arms in Borough limits. Dee referred to Lienhard and Philly shooters. Chief Schatz relying on voluntary compliance. Chief is instructing to call in, but JTPD is saying there's nothing they can do. Referenced shooting incident. Dee has visited neighborhoods of council members and wants to know plan of action? Will come to every meeting until something is done.

Streets & Sidewalk Ordinance Update – curb regulations – Jay Miller – Church Alley Project is coming along nice, the contractor needs more crews. Curbing – Council to review & comment. Michael J Yeastedt – solicitor rewrote and updated ordinance.

### Police

Parking – 1<sup>st</sup> Block of Broadway – Authorize Chief to research class and size of vehicle. Motion by Jay Miller second Robert Schaninger to authorize Chief Schatz to research class and size of vehicles for possible restrictions. There were no comments. Motion carried 4 to 0. Chief – in contact with Dave Drury from Inn of Jim Thorpe on ingress and egress of their lot. Jay Miller- can kiosk issue message on ticket, open discussion on "subcompact" only, reference to photos taken by Chief Schatz, discuss marking with lines and discuss current car types. Mike Rivkin comments that vehicle classifications are skewed, solicitor advises Rifkin to be careful with wording, maybe just needs to fit within lines (add "T's" to end of lines). Mayor – worried about losing parking spots and meter income, 1/3 of a mill is approximately \$30,000.

Diligent Bay Window & Woodwork – awaiting updated written quotes – per Jay Miller we're still waiting for quote update.

Young Lungs at Play – Tobacco Free Policy – Greg stated to start with policy to address smoking. Mayor asked if medical marijuana is covered under the policy. Bob referenced all the facilities that he visits have "tobacco free" policies. Jay was not opposed, just asked questions. Open discussion on tobacco types. Needs further discussion, leave under committees.
