Meeting was called to order by President Gregory Strubinger at 6:30 p.m. in the Memorial Hall, 103 East Tenth St, with the Pledge of Allegiance and a moment of silence for the men and women serving our country.

Ryan Richards was present to discuss the 2015 CDBG funds. The borough would like to move \$60,000.00 from the year 2015 Water Improvement/Penn Vest loan payment to the following projects: \$58,595.40 to Water Improvement/7th St water main replacement

\$ 1,404.60 to Water Improvements/5th St & South St (this is an existing project with a revised cost of estimate of \$13,436.60)

Spillman Farmer - Blaine Summitt and Salvatore Verrastro

Sal Verrastro gave an update on the feasibility study on the current facilities and how to use them to the best interest to the borough. They presented council with a copy of the study they have been working on for the borough.

Blaine Summit said they are working on the Public Service garage. This building is not adequate for the street dept. They are looking at 150' x 150' garage for the Public Works dept. this would house all of the equipment in it and they would move this to another location.

Right now the borough office and police dept. share the same structure. This is not enough space and the security is not adequate. The Police dept. needs an evidence room, training room, interview room, holding cell, ammo room, file room and offices. They looked at the Memorial hall this is the emergency shelter so you wouldn't want to get rid of the kitchen area.

Three solutions:

- 1.) Leave the Administration in the current building and expand.
- 2.) JTPD moved to the top floor in the Memorial Hall with making the hall half the size Keeping the kitchen area for emergency shelter
- 3.) JTPD in the skating rink.

Sal Verrastro said the police station being in the basement of the hall is out of the way but is a more secure place for the department with more space to expand.

Mr. McGuire said this is a great solution. This gives them room to expand. The administration building was put in the reason that was put in the size that it was, was not to encroach on the memorial park grounds. It was designed much bigger. With moving the public works dept. that will give much more back to the park.

President Strubinger said he would like to see this be used as a community center.

Sal Verrastro said this does not all have to be done at the same time this can be done in pieces. With the hall being downsized it will still hold 250 people that is without a dance floor. The estimated cost for the project is \$1.8 million dollars. We are looking at what is more feasible for the borough.

Mr. McGuire asked that they look at a building for the emergency services also.

The feasibility study was discussed for several minutes. Copy of the feasibility study is attached to the borough office minutes.

A resident said he would suggest the Police Dept be on the top floor.

Mayor's Report

Mayor Sofranko said everyone received a copy of the police report.

Mayor Sofranko said the Police Chief is working hard to get a patrol car around in town so it shows the police depts. presence in town.

He said the traffic citations that have been issued there is a least 30 tickets a months, that is one a day.

Mayor Sofranko asked that council accept Jamie Solomon's letter of retirement. The Chief, Manager and Jamie sat and worked on a job description.

Mayor Sofranko said they will get dates together to sit and discuss the lot parking rent.

Mayor Sofranko said they will be doing a traffic study for Route 903 to compare the studies in the past. He will need a letter from the manager to Penn Dot that this be done for the borough.

Mayor Sofranko said there will be no National Night out this year. The lady that did this has other obligations this year. They will schedule sometime in July or August to discuss the drug issues in Jim Thorpe.

Mayor Sofranko said the petition to save the old bridge the point to be made is there are only 80 residents on this. He spoke to Hefley's office and there is an individual that has contacted the state that is interested in purchasing the bridge, none of this has been confirmed. It is under contract that the bridge is to be torn down and there is a penalty if it's not torn down by a certain time.

President Strubinger said the main concern for the borough is that there is no liability to the borough no matter what happens.

Mayor Sofranko said we will need something in writing in the bank, that if something would happen to the old bridge or become an eye sore to the borough that there is money to remove that bridge and tear it down. What we need is a letter to go out to Penn Dot so there is something on file that we would like it to be torn down.

Mr. Miller said liability we have no liability to that bridge now, we do not and we do not want the liability for this bridge. Penn Dot has found that bridge that it is not sound and that it must come down. That is coming down because it has to come down.

Police Chief Schatz said he spoke with Penn Forest fire police they will be coming down to help them out with the 4th of July festival traffic same as last year.

Public Comment

Todd Konstas said he is the person that started the petition to keep the bridge. Most people thought this is a good idea. What inspired him is the High Line bridge that is in Manhattan. They saved the bridge and it's a walking bridge in NY. He thought it should be saved as a pedestrian bridge/park. Jim Thorpe is unique he is not asking the borough to take it over or liability of it, he is just asking the borough to support this.

Mr. Miller said he was here 25 years ago when Penn Dot closed the bridge. The same buttress they temporarily put there 25 years ago is still there. It is the same thing that is supporting that bridge now. They are putting a brand new bridge above it because this one is not safe, it is not safe for the future. This has to come down. He does not understand why we would save something that has been determined structurally unsound. This would bankrupt the town. This is under contract to demolish the bridge, it's about \$1.4 million to demolish, this is not feasible, this is out of the reach.

Donovan Rhoads, Boy Scout troop is present, he is working on his communication badge.

Bill Malatak asked solicitor Nanovic what obligations do we have to respond to the emergencies at the Glen Onoko.

Mayor Sofranko said the Police do not go unless they are requested by the State Police to be there. The volunteer fireman that are taking the brunt of this.

Mr. Miller said the fuel that is put in the fire trucks is paid by the borough. They passed an ordinance so they can start charging people for the Fire depts. Services. This is State game lands that they are going onto. This takes about 5 or 6 communities that work on these calls.

Mayor Sofranko said this is a volunteer fire staff.

Mr. McGuire said we need to push the State to change this, this needs to be something like Bushkill Falls. They need to change this to a park so they can do something about this. Bushkill has set walkway with ropes going up along the trail to stay away from the falls. Until this becomes a park nothing is going to happen up there.

Bill Malatak congratulated the Borough Manager – Maureen for 6 months here. He spoke about the D & L pedestrian bridge by the sewer plant. We need to discuss the tourism in Jim Thorpe, (the old bridge) The Jim Thorpe residents are going to have to walk all the way around to get to the downtown section. The sidewalks end by the telephone pole and to get to the parking lot we get nothing out of the parking lot, from the telephone pole to the train station that is a disgrace. People are trying to walk down past the parking meters and its difficult. That is a safety issue.

Manager Sterner said she spoke to Commissioner Nothstein and he gave her some information to review.

Connor Rodgers asked if it could be possible to get the cross walks painting throughout town.

PSM Yaich said this will be done in the next 2 weeks.

Andrew Roberts said he has seen the police dept. patrolling more on the west side of town and he is glad to see this.

Andrew Roberts said his neighbor got a street/sidewalk permit and paid \$5.00 for that, he does not believe this 383.36 sidewalk repair fee is free. He asked council to look at the fee schedule more and look at this in full. He submitted a right-to-know request for the updated fee schedule and he was denied by the borough. He knows he does not have to be given this information but he feels he was helpful the last round with the fee schedule. The other item is the zoning hearing board numbers He would like to know what is going on with the property at 56 W Broadway.

Curtis Jackson said the early planning stages of the bridge, he thought as the existing bridge is coming down the last part of the project is to rebuild the wall coming from the old bridge towards Subway, which would include that walkway. You may want to check on this.

Jerry Strubinger, Council should be getting reports on the Route 903 bridge project. Council should be spearheading what is going on there. The point he brings up tonight the middle pier that is in the river they are reinforcing this, something went wrong. What went wrong?

He said council should be getting reports on this. You should be getting financial reports on this project also. He said twisting piers in the middle of the river, that is horrible, that is a crime and should be reported to the people. Council should be giving a report on this bridge.

Manager Sterner said she inquired to Calvin Ulshafer (Penn Dot rep) he said the work they had done in the river, they were doing at the time of the year it was permitted to do it. They are just going back in to finish that job.

Mark Reitz, 529 North St, he has met all the obligations with zoning, fire control, etc. The Police have helped him out. He has gone into Vacation Rental By Owner (VRBO). He was sent a letter from the County that he now has to pay the 3% amusement tax. Now he is seeing over 300 on the website. He would like to know any of the other people that have the VRBO have gone through the proper procedure to rent a room in the home, there is no control.

Manger Sterner said we can only address the VRBO in Jim Thorpe Borough. She asked him to come into the borough and fill out a request form for us to look the information up.

Mr. McGuire asked that we contact the County for their list of VRBO's in Jim Thorpe.

Mr. Miller said we become aware of things we should turn it over to zoning and they should have to go through the same hoops. We have to find out what is happening. If they have to bring it up to specs they have to, we are responsible for the fire code.

Curtis Jackson said Air B & B, transient/sharing hospitality are zoning doesn't address this. This should go to Planning to address this.








